The United States education system has for some time operated without a formalised, national qualifications framework. However, this is going to change through the development of the United States Qualification Framework (USQF).

National frameworks can provide formalised structure and order and facilitate improved understanding of the complexities of particular education systems and of the qualifications offered within them.

In this session, representatives from the recently established USQF Advisory Council will share the details of this exciting development. The session will explore the plans and objectives behind the USQF, its design and potential features and the anticipated benefits to stakeholders in-country, within North America and across the world.

Employability and post-completion quality assurance

Post-completion outcomes are a critical measure of program quality but have not historically been given the same attention as completion and "student success". That is changing, with increasing scrutiny from policymakers and the public around post-secondary return-on-investment. Attention to employability is relevant to every field of study.

In this session, we will explore elements of QA Commons' Employability Framework, with case studies for each of the framework's five standards of care:

- Development of essential employability qualities
- Career and integrated support services
- Employer engagement
- Student and alumni engagement
- Public information

Participants will have the opportunity to engage in a Q&A session with leaders from "EEQ Certified" programs identified as having noteworthy practices.

The international potential of China's college students

The vocational college sector in China is enormous, with over 10 million students. There is huge potential for international exchanges and student progression arrangements such as top-ups from diploma to degree. The colleges have done much internationalisation work, including working with Ecctis to benchmark and develop curriculum to international standards and formats. However, barriers remain to Chinese college students' international mobility.

Four China college principals discuss these barriers and how they might be overcome, and highlight the internationalisation work being done now and the potential for partnerships that could do more. (With translation from Chinese to English.)

International education closer to home: the International Association of Education Hubs

The COVID 19 pandemic, growing international security threats and environmental concerns, as well as deepening global economic crisis, are amongst the factors that are affecting the demand and supply of international education. In particular, there is now a growing demand for international education 'closer to home', for example through Transnational Education and online learning, but also through flexible pathways to international education, including periods of study in different locations and institutions. International education hubs are ideally placed to respond to these challenges and opportunities. Five international education hubs, including EduCity Iskandar (Malaysia), Uniciti (Maurities), Incheon Global Campus (South Korea), Ras al Khaimah Academic Zone (UAE), and Hainan Pilote Zone (China), have decided to come together into an International Association of Education Hubs (IAEH) to share lessons learned, best practices and explore ways in which they can cooperate in developing innovative and needed solutions to today's current internationalisation challenges and opportunities.

This session will introduce the International Association of Education Hubs (IAEH), highlighting its mission, goals, and initiatives, as well as introducing the different models and ways of

operating adopted by the different IAEH member hubs. Panellists representing the different hubs will discuss challenges and opportunities associated with current changing dynamics in the international education landscape and how the IAEH and its member hubs can contribute to respond to them.

The panel session will encourage interaction and discussion with delegates. Critical to realising the goals and objectives of the IAEH is in fact engaging with relevant international stakeholders, such as international education providers, regulators and government authorities, and service providers, as well as students. The panel session will be an important opportunity for facilitating such engagement.

India/UK – Memorandum of Understanding

The landmark memorandum of understanding (MOU) between India and the UK opens up opportunities for higher education collaboration, and will better enable two-way student mobility, whilst also significantly improving workforce mobility. The MOU is a symbolic marker in the UK-India relationship. It supports greater two-way mobility for both students and skilled workers, opening up opportunities for UK and Indian citizens.

The MOU will specifically benefit Indian students wishing to study degrees in the UK and wishing to return home to either work in government, or for additional education at Indian universities. Added potential benefits of the removal of current barriers to recognition are significant boosts to education exports, exchanges, and partnerships; more research collaborations; and more forms of transnational education (TNE) where UK degree programmes - in particular through branch campuses - can be delivered in India, and vice versa.

This session will highlight the benefits of the MOU to UK providers and we will learn how the agreement benefits India and Indian higher education.

How project-based learning and integrated skills prepare students for university and beyond

School is more than just a factory that churns out students with a set of exam results, it is a place where they gain the skills they need to be successful in the next stage of their life: university and the world of work.

Universities, and employers, have long stated that they need young people capable of independent analytical thought, not just robots who can recall facts and information. Project-based learning is the bridge that allows students to gain these key skills: independence, critical thinking, extended critical argument, time management. This way, they arrive at university armed with more than just subject knowledge, they have the critical capacity to engage with higher-level learning.

It is small wonder that independent project qualifications have been gaining popularity over the last 15 years, with many universities now offering differentiated entry offers for students who apply with a project qualification alongside their other results.

This session will explore:

- The benefits of project-based qualifications for students in preparing them for future study
- How assessing integrated skills can give a more accurate view of students' readiness for university.
